Agencies' programs must address identified community needs, track program outcomes and achieve positive results in the following impact areas: basic needs (emergency food, clothing, & shelter), youth programs, medical assisant/health care programs, and elderly citizens & adults with disabilities. Approximately 22 programs were funded annually. United Way of Marquette County provides donors with a choice in its annual pledge drive. Contributions can be designated to a specific 501(c)3 health and human service organization serving Marquette County or contributions can be undesignated and allocated to agencies via the review process. United Way cannot guarantee how undesignated funds will be used.
